## REGUPOL SONUS MULTI 3

The **REGUPOL sonus multi 3** acoustic underlay is a high-performance solution specifically engineered to minimize the transmission of impact sound, such as footfall noise, in various living and working environments.

Its unique composition of pre-consumer polyurethane foam and cork elastomer, combined with a factory-sanded smooth surface, allows for effective bonding with a range of resilient floor coverings, including sheet vinyl, vinyl planks, carpet tiles, and cork. Additionally, the absence of SBR rubber in the underlay composition avoids issues such as plasticiser migration, delamination, and discolouration.

For those considering soundproofing their resilient floors, it is important to verify with the manufacturer that the

specific brand, type, and thickness of vinyl are approved for use with the **REGUPOL sonus multi 3** acoustic underlay and the appropriate adhesives. This not only guarantees the performance of the soundproofing system but also preserves the warranty of the products used.

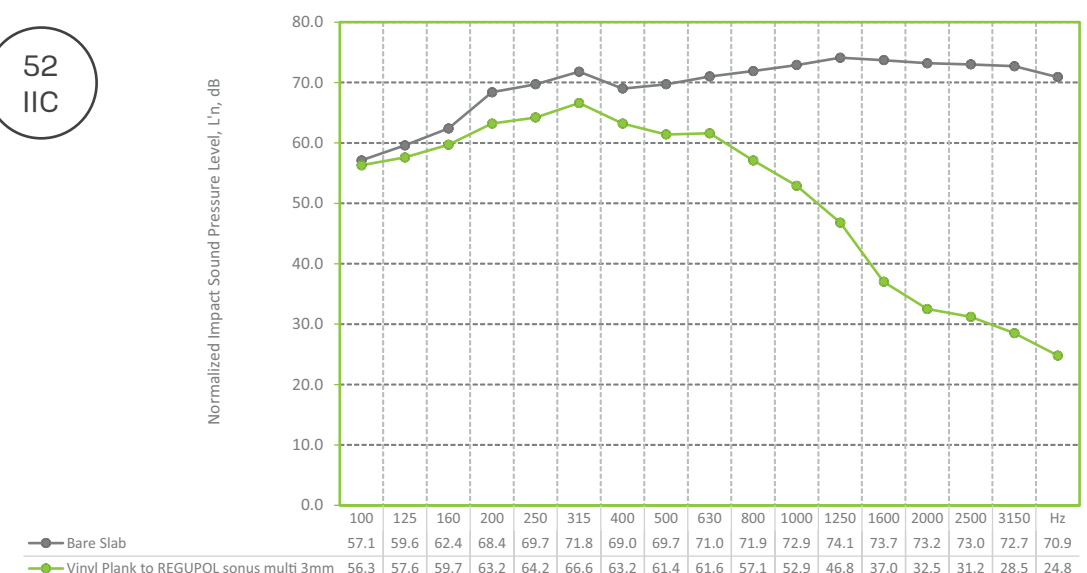
### ACOUSTICAL PERFORMANCE

#### VINYL PLANK Normalized Impact Sound Pressure Levels

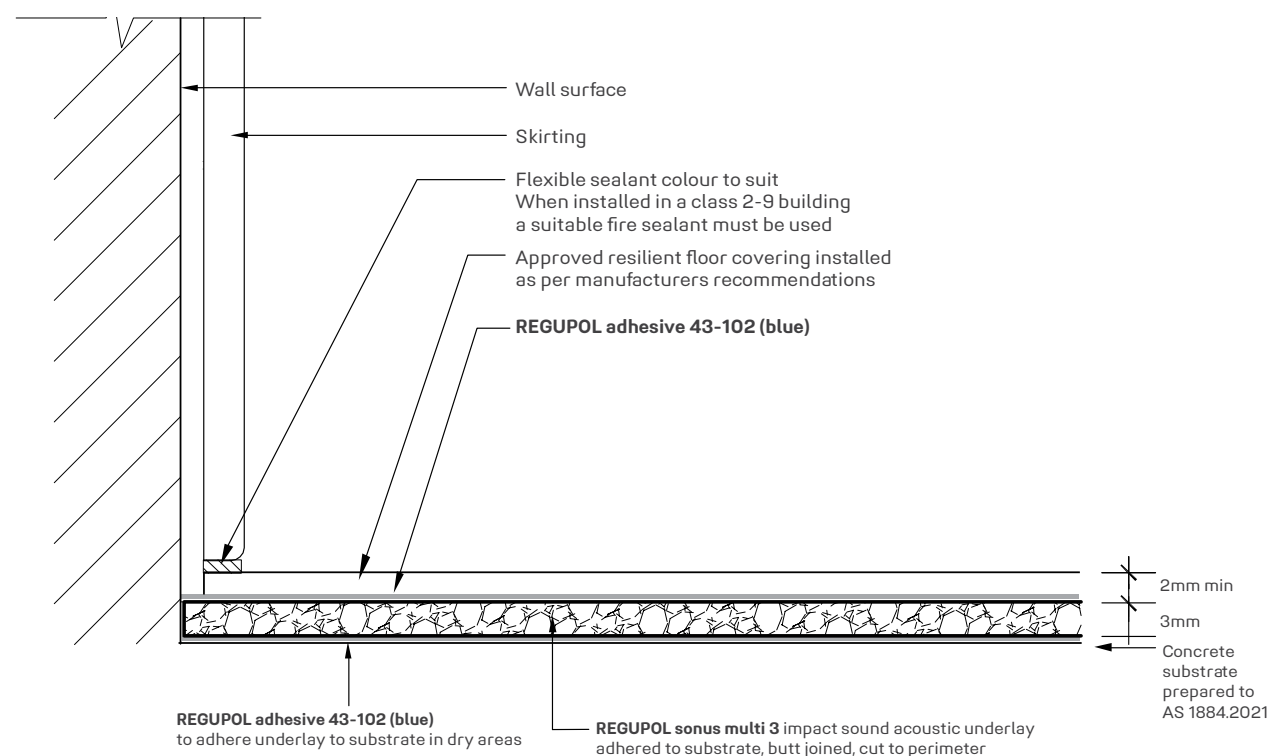
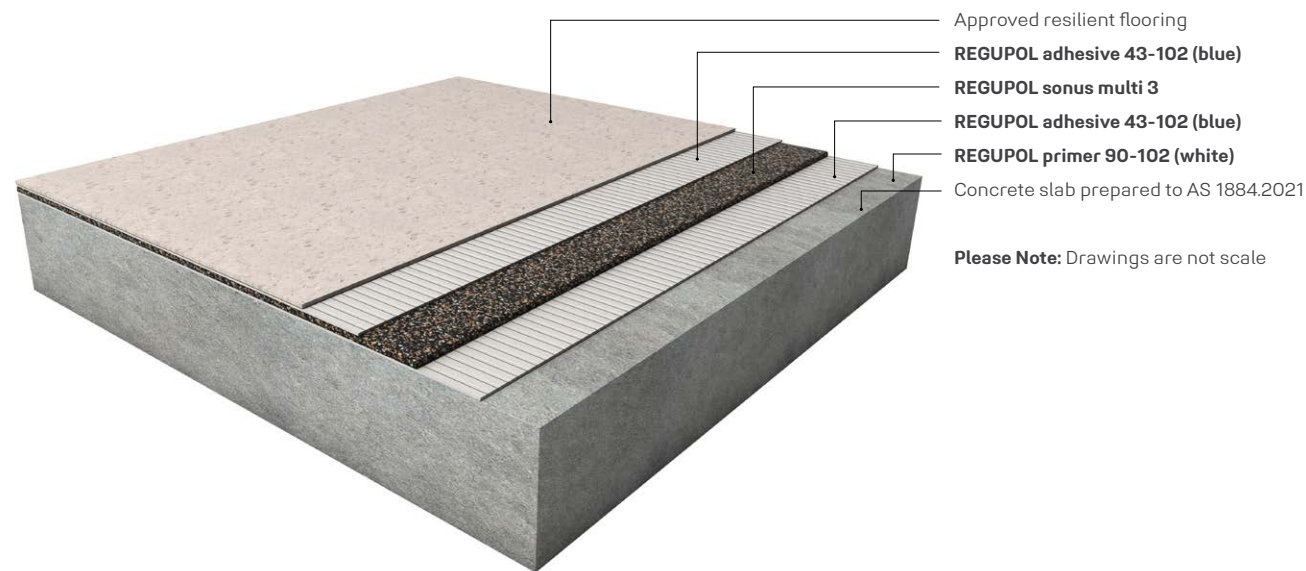




## INSTALLATION IN DRY AREAS USING REGUPOL adhesive 43-102 (blue)

**REGUPOL adhesive 43-102 (blue)** multi-use flooring adhesive is a versatile, water-based polymer adhesive designed to securely bond **REGUPOL sonus** acoustic underlay products to concrete and various approved substrates. It is suitable for indoor dry-area installations. However, it is important to note that this adhesive is unsuitable for wet, external, high-thermal and high-impact applications, so it should be used within specified conditions to maintain its effectiveness. For porous substrates, apply the **REGUPOL primer 90-102 (white)**.

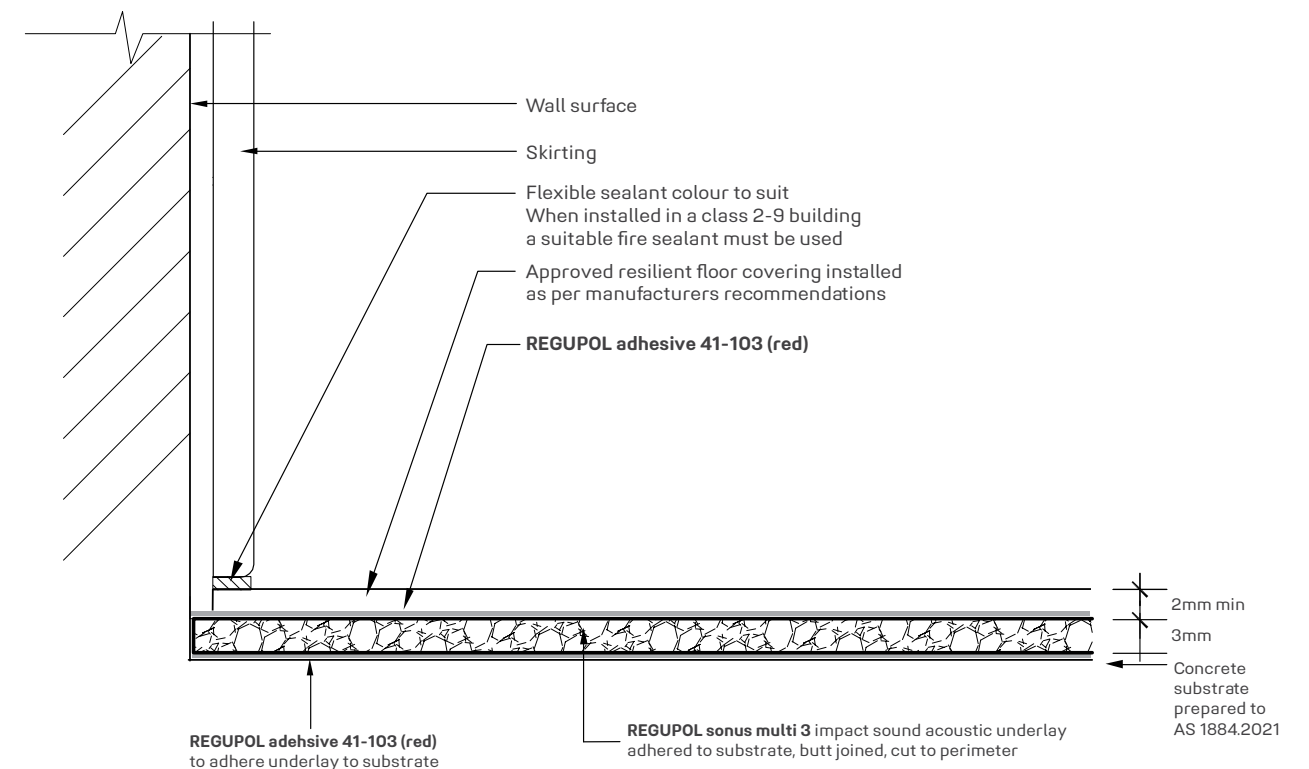
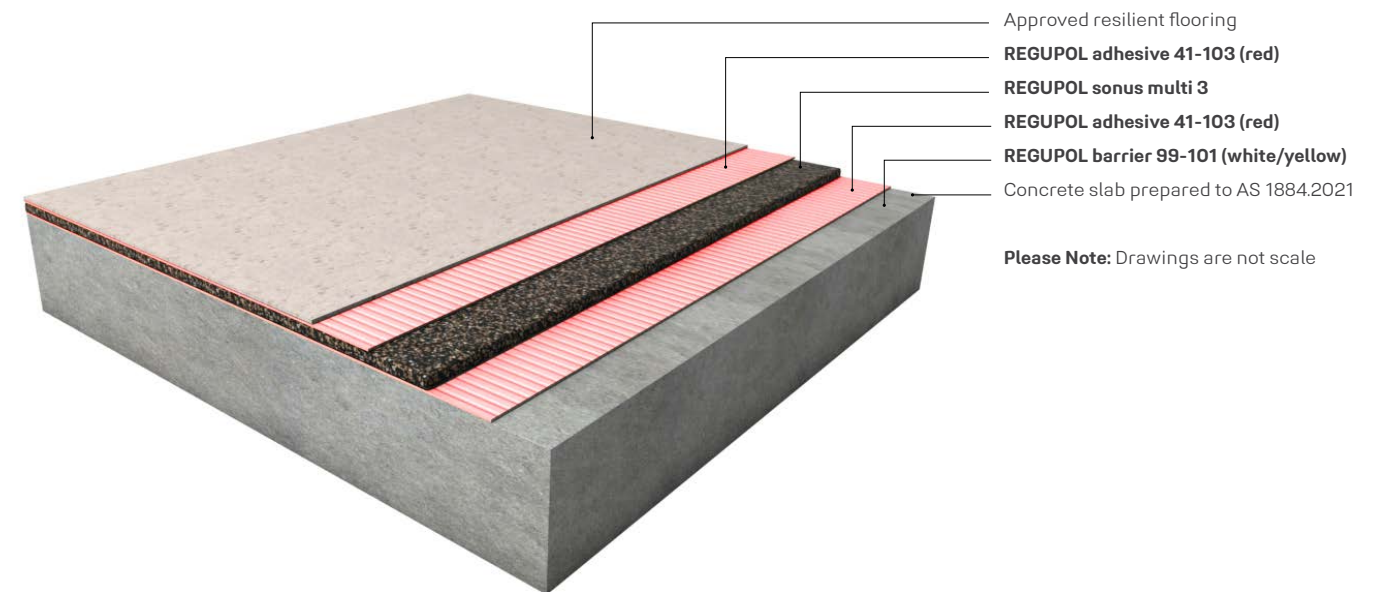
Ensuring the compatibility of the **REGUPOL sonus** acoustic underlay product with the selected primer, moisture barrier, and adhesive/s with the substrate is a vital step in the installation process. **REGUPOL** offers many detailed installation guides for various product applications and systems. It is recommended that these resources be reviewed thoroughly before beginning the installation of this product.



## INSTALLATION IN OTHER AREAS USING REGUPOL adhesive 41-103 (red)

**REGUPOL adhesive 41-103 (red)** resilient two-part adhesive is a specialised two-part polyurethane product designed for bonding **REGUPOL sonus** acoustic underlays products. It is particularly effective in environments that experience high impact, significant temperature fluctuations, and exposure to sunlight. Some vinyl manufacturers also prefer this adhesive for warranty purposes. Apply the **REGUPOL barrier 99-101 (white/yellow)** if the moisture content in the subfloor exceeds the required levels.

**REGUPOL** do not provide wet area details for approved resilient floors over **REGUPOL sonus multi 3** acoustic underlay. This should be obtained by a waterproofing company or consultant for further advice. Alternatively, considering one of our **REGUPOL sonus** under screed systems may be more beneficial.
